What a busy month we've had. Many of our residents attended and enjoyed the many events our Social and Activities Directors planned...Cinco de Mayo, dance with Mark and Miller, Mother's Day Dance and Mother's Day Breakfast. All were hugely successful and thanks to all our volunteers who helped to make them such a huge success! Bill Wiseman, FLE HOA Vice President, and I had a meeting with Vickie on May 10th and I want to share the important items that came up.

- 1. The table outside the new pickleball area is temporary until they get the new benches.
- 2. We discussed parking issues in the park. There is NO parking on lawns and sidewalks. Some cars are getting notices on cars parked on streets after 7AM. Vickie said her crew comes in at 7 and if it is apparent it has been parked there overnight (dew on windows and hoods), then they will be ticketed. Also, if cars are parked in guest parking areas without prior approval, then they could be towed too. Simple answer—follow the parking rules.
- 3. Repairing kitchen air conditioner.
- ELS have not directed the USPS to stop delivering store flyers and coupons to residents. I'll be meeting with Zephyrhills Postmaster in the near future to discuss this.
- 5. Discussed another cable company, i.e. Frontier Cable, coming into the park. Vickie indicated that she thought they have an exclusivity agreement with Spectrum but does not know when it expires. She will get back to us on this as I told her we need other options to help lower our expenses.

- 6. ELS is not in the cable business and will not provide bulk cable in the park.
- A question arose about selling homes in the park.
 You can use a realtor or sell your home yourself. If you are selling your home and want a 360-inspection done in advance, you must provide the office with the contract or web listing.
- 8. Vickie made it clear that full time RV Park residents are considered guests when they visit our park. If they participate in any of the FLE HOA activities, they must sign in as a guest. This ensures they are covered by our insurance policy while participating in HOA activities/events.
- Vickie is in the process of getting the pool chair lift fixed. It was damaged during one of our recent storms.
- 10. Animal control responsibilities: Pasco County Animal Control are only responsible for cats and dogs. Any other animal/rodent, i.e. gators, raccoons, etc., is the responsibility of Florida Fish and Wildlife. Vickie stated that her maintenance crew will not go after raccoons or other diseased animals. She does not want them bitten either. Just leave them alone and when they die, her maintenance crew will pick up the dead animal.

Just a reminder that we will be holding a Town Hall meeting in the Clubhouse on June 6 at 6PM with Sunshine Water to discuss any issues we may be having with our water. This will be a good opportunity for our residents to hear directly from Sunshine Water on future improvements and issues/concerns we may have.
